THE RULES

Contest Period.

The contest runs from April 22nd, 2013 12:00PM Central Time, to 4:30 PM Central Time on May 10th, 2013. Entries must be received by the FireSpirit Inc within that period to be eligible.

2. How to Enter.

You may enter the contest by submitting your logo to us via email at lawrence.daniels@fire-spirit.ca. Your email must include: (a) your full name, mailing address, telephone number, and age, (b), a synopsis of your logo (no longer than 100 words), (c) a copy of your logo in JPEG, PDF or EPS format with a maximum file size of 10 MB, and (d) a statement that you agree with the contest rules that can be obtained upon request at firespirit@fire-spirit.ca

3. Eligibility – Entrants.

You are not required to make any purchase or pay any fee to enter or win the contest.

You may only enter the contest if you are an individual and, at the time of entry: (1) you are a participant or former participant in a FireSpirit program or are a member of the OCN (2) you are at least 18 years old, or you have consent from your parent to enter the contest and agree to these rules.

FireSpirit employees and their immediate families (i.e., their spouses, siblings, children, spouses’ parents, and the spouses of any of those individuals) and their household members (related or not), and anyone otherwise connected with the contest, are not eligible to enter the contest.
